Disclaimer: The exclusion lists for publication in this document are currently under update. The document should thus be read with the reservation that it may not be fully reflective of what is now excluded under each category

Investment exclusions form an integral part of Danske Bank's approach to responsible investments. They serve to safeguard our customers' assets and enhance the risk-adjusted return on our investments, but also to reduce our investments' negative impact on society.

Investment products managed by Danske Bank therefore to a large extent apply exclusions as an integral part of their strategies. The level of exclusions that apply varies depending on the specific strategy under management as we strive to design our investment product offering so that it caters for the different preferences of the customers. All investment products that are promoted with exclusions as an integral part of the investment strategy apply a combination of base exclusions considering a combination of environmental as well as social and governance related aspects. These exclusions cover exclusions relating to:

- Minimum social, environmental standards and good governance exclusions under our [Enhanced Sustainability Standards](#) (incl. country exclusions)

For Danske Invest branded products under management these base exclusions are supplemented by standard exclusions on [Pornography](#). All Danske Invest branded products marketed towards our Norwegian customers also always have exclusions, [SPU Exclusions](#), replicating those of the Norwegian Bank (Statens Pensjons Utland). For certain investment products we apply an even more extended range of exclusions, covering not only the exclusions listed above, but in addition a combination of some or all exclusions relating to:

Specific investments covered by thermal coal exclusions or fossil fuel exclusions may be exempted from exclusions in accordance with the principles set out in the Exclusion Instruction. Also, the Responsible Investment Committee may in extraordinary cases decide to allow for an investment product to stay invested in a investment otherwise excluded by the product. Investment products making sustainable investments meet our restricted criteria defined for the so-called "principal adverse impact indicators" in respect to these investments. We refer to these restricted criteria as [PAI-Exclusions](#). For those investment products that invest partially in sustainable investments, the PAI-exclusions only apply to those investments. For investments products investing with the objective to invest only in sustainable investments, the PAI-Exclusions apply to the full product.

The screening of companies and other issues covered by the exclusions is carried out at a bi-annual basis resulting in updated exclusion lists under each category. For that purpose we primarily use external data sources, which are continuously assessed by Danske Bank's Responsible Investment team. Despite thorough due diligence and efforts to ensure data accuracy, completeness, and reliability, there may however still be a margin of error associated to the screening due to data inconsistencies.

The exclusion lists cover direct investments in instruments (e.g. equity, bonds) issued by the respective companies and issues, this also includes sustainability labelled bonds issued by excluded issuers. Affiliation to an excluded issuer does in principle not trigger an exclusion of other issuers. Sovereign based exclusions can also capture other related issuers such as state-owned enterprises. The exclusion lists do not cover indirect exposures to the issuers gained via the use of derivatives.

This document reflect the currently applicable exclusion lists under each exclusion category. This means that companies/issuers mentioned on each of the lists with a few exemptions or non-investable for those products that apply the relevant exclusions corresponding to that list. Due to market conditions and client interests, some listed companies/countries may still be present in portfolios but are targeted for divestment.

Exemptions from exclusions may be granted to certain issuers if justified by fiduciary duties and approved per internal governance. Relevant issuers are noted at the end of the document, along with information on companies identified as transition cases per the thermal coal and fossil fuel exclusions.

Exclusions applicable to all investment products promoting exclusions in investment strategies

Enhanced Sustainability Standards

The enhanced sustainability standards screening is Danske Bank's proprietary screening model that supports the exclusion of certain companies/issuers engaged in certain activities and conduct deemed harmful to society. The exclusions apply fully to all investment products and pension products manufactured within Danske Bank disclosing this to investors.

The enhanced screening is a multidimensional process assessing both environmental materiality as well as social materiality in order to promote adherence to UN Global Compact, principles, OECD Guidelines for Multinational Enterprises, UN Guiding Principles on Business and Human Rights and ILO conventions and other relevant environmental or social safeguards by its exclusions.

The screening also seeks to capture certain other activities indicating weak sustainability practices (in particular) by addressing controversies and Danske Bank Position Statements as well as weak governance practices governance practices are addressed through the good governance test outlined below.

The Enhanced Sustainability Standards screening process currently consists of three sub-processes:

Tar Sands

Tar sands, also known as oil sands, heavy oil, crude bitumen, or more technically bituminous sands, are a type of unconventional petroleum deposit. Tar sands are either loose sands or partially consolidated sandstone containing a naturally occurring mixture of sand, clay, and water, saturated with a dense and extremely viscous form of petroleum technically referred to as bitumen (or colloquially as tar due to its superficially similar appearance).
