This Prospectus Supplement dated 11 February 2011 (the "Prospectus Supplement" or "Prospectus Supplement No. 4") to the Base Prospectus dated 25 March 2010 (as supplemented by the Prospectus Supplement No. 1 dated 5 May 2010, the Prospectus Supplement No. 2 dated 12 August 2010 and the Prospectus Supplement No. 3 dated 4 November 2010) (together, the "Base Prospectus") constitutes a prospectus supplement for the purposes of article 13 of Chapter 1 of Part II of the Luxembourg Law dated 10 July 2005 on prospectuses for securities (the "Prospectus Law") and is prepared in connection with the Euro Medium Term Note Programme (the "Programme") established by Danske Bank A/S (the "Issuer"). Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement.

This Prospectus Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus.

The Issuer accepts responsibility for the information contained in this Prospectus Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Prospectus Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

- 9. Since 31 December 2010, the last day of the financial period in respect of which the most recent audited financial statements of the Issuer have been prepared, save as disclosed herein, there has been no significant change in the financial or trading position nor any material adverse change in the financial position or prospects of the Issuer or of the Issuer and its subsidiaries taken as a whole."

To the extent that there is any inconsistency between (a) any statement in this Prospectus Supplement or any statement incorporated by reference into the Base Prospectus by this Prospectus Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Prospectus Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.

See "Risk Factors" in the Base Prospectus for a discussion of certain risks that should be considered in connection with certain types of Notes which may be offered under the Programme.
