EUR 35,000,000,000 EURO MEDIUM TERM NOTE PROGRAMME

This Prospectus Supplement dated 23 June 2015 (the "Prospectus Supplement" or "Prospectus Supplement No. 2") to the Base Prospectus dated 9 February 2015 (as supplemented by the Prospectus Supplement No. 1 dated 7 May 2015, together with the Prospectus Supplement, the "Base Prospectus") constitutes a supplement for the purposes of Article 16 of Directive 2003/71/EC, as amended (the "Prospectus Directive") and is prepared in connection with the Euro Medium Term Note Programme (the "Programme") established by Danske Bank A/S (the "Issuer"). Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement.

This Prospectus Supplement has been approved by the Central Bank of Ireland as competent authority under the Prospectus Directive. The Central Bank of Ireland only approves this Prospectus Supplement as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.

The Issuer accepts responsibility for the information contained in this Prospectus Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Prospectus Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

RECENT DEVELOPMENTS

In Company Announcement No. 21/2015 released on 17 June 2015, Danske Bank A/S announced that Moody's Investors Service Ltd. ("**Moody's**") has upgraded Danske Bank's long-term rating to A2 from A3 and its short-term rating to P-1 from P-2. Outlook remains stable.
