This Prospectus Supplement dated 27 July 2022 (the "Prospectus Supplement" or "Prospectus Supplement No. 3") to the Base Prospectus dated 9 November 2021 (as supplemented by the Prospectus Supplement No. 1 dated 3 February 2022 and the Prospectus Supplement No. 2 dated 29 April 2022, together with the Prospectus Supplement, the "Base Prospectus") constitutes a supplement for the purposes of Regulation (EU) 2017/1129 (the "Prospectus Regulation") and is prepared in connection with the Global Covered Bond Programme (the "Programme") established by Danske Bank A/S (the "Issuer"). Terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement.
