This Prospectus Supplement dated 24 July 2023 (the "**Prospectus Supplement**" or "**Prospectus Supplement No. 4**") to the Base Prospectus dated 9 November 2022 (as supplemented by the Prospectus Supplement No. 1 dated 3 February 2023, the Prospectus Supplement No. 2 dated 28 April 2023 and the Prospectus Supplement No. 3 dated 12 June 2023, together with the Prospectus Supplement, the "**Base Prospectus**") constitutes a supplement for the purposes of Regulation (EU) 2017/1129 (the "**Prospectus Regulation**") and is prepared in connection with the Global Covered Bond Programme (the "**Programme**") established by Danske Bank A/S (the "**Issuer**").
