This Prospectus Supplement dated 8 February 2021 (the "Prospectus Supplement" or "Prospectus Supplement No. 3") to the Base Prospectus dated 17 June 2020 (as supplemented by the Prospectus Supplement No. 1 dated 22 July 2020 and Prospectus Supplement No. 2 dated 9 November 2020 together with the Prospectus Supplements, the "Base Prospectus") constitutes a supplement for the purposes of Regulation (EU) 2017/1129 (the "Prospectus Regulation") and is prepared in connection with the Structured Note Programme (the "Programme") established by Danske Bank A/S (the "Issuer").
